AUDITOR'S REPORT

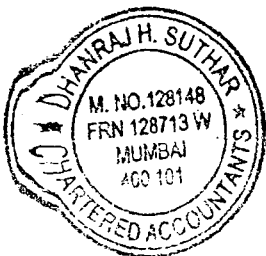




